Policy highlights

- New vehicle replacement in the event of total loss if your vehicle is a sedan, station wagon, 4WD, utility or other goods carrying vehicle;
 - if the vehicle is less than two years' old and has a payload carrying capacity no greater than five tonnes
 - if the vehicle is between two and less than four years' old, has a payload carrying capacity no greater than two tonnes and is under 100,000 kms with prior Zurich insurance taken out within two years of the date of first registration and maintained continuously
- Automatic cover for a new vehicle within 60 days up to \$300,000 per vehicle
- Driver's personal property up to \$500 per event (\$2,000 max per one period of insurance)
- Emergency replacement of windscreens/windows
- Emergency towing of vehicle to nearest repairer
- Coverage of employees' vehicles up to \$50,000 per any one loss or event
- Hire vehicle following theft up to \$5,000 per vehicle
- Journey disruption including the reasonable cost of transport, overnight accommodation, hiring another vehicle up to a maximum of \$3,000 per event

- Locks and or key replacement up to \$5,000 per event with no excess if no other loss or damage has occurred
- The reasonable costs of replacing signwriting on your vehicle
- In the event of total loss of encumbered vehicles up to an additional 20 per cent limit of market value or sum insured value or agreed value, whichever is lesser
- Removal of debris or load costs up to \$25,000 per event
- Retrieval costs if immobilised, up to \$25,000 per period of insurance
